

THE CORPORATION OF THE TOWN OF IROQUOIS FALLS

BY-LAW NO. 3674/22

"Being a by-law to impose fees and charges for cemetery products and services."

- WHEREAS** Section 391 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, authorizes a municipality to impose fees or charges on persons for services or activities provided, or done by, or done on behalf of it;
- AND WHEREAS** Section 398 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that fees and charges imposed by a municipality on a person constitute a debt of the person to the municipality;
- AND WHEREAS** O. Reg. 30/11, Funeral, Burial and Cremation Services Act, 2002, requires that a percentage of the purchase price of all interment rights, and set amounts for marker and monument installations, are contributed into a care and maintenance fund;
- AND WHEREAS** The Corporation of the Town of Iroquois Falls owns several cemeteries within its municipal boundaries;
- AND WHEREAS** Council for The Corporation of the Town of Iroquois Falls deems it necessary to adopt a price list with fees and charges for cemetery products and services.

NOW THEREFORE, COUNCIL FOR THE CORPORATION OF THE TOWN OF IROQUOIS FALLS ENACTS AS FOLLOWS:

1. That the fees and charges be set as per Schedule "A".
2. That interest for unpaid amounts owing for fees and charges shall be imposed at the rate of 1.25 percent, per month, of the amount in default.
3. That the treasurer may add the fees and charges imposed by the municipality to the tax roll of the property to which all of the owners are responsible for paying the fees and charges.
4. This by-law shall come into effect upon its passing.
5. That By-Law No. 3364-16 is repealed.

Read a **FIRST, SECOND, and THIRD** time and passed this 25th day of April, 2022.

PAYMENT
